- The stairs to the front door have a steel stringer and timber balustrading.
- Door schedule
 - The panel doors appear to have a 6 pane FG panel at the top. Is this correct?
 - Remove FG where there is no glass to the doors eg Bed 2 door D0.5. Is the highlight for the doors a timber breezeway / fanlite. Please amend accordingly.
