Consent to Electronic Communications

(CEC) (09/2017.2)

The parties are proposing to enter into a building contract ("Contract") and would like the option of doing so by electronic communications, that is, by sending to, and receiving from, the other party, all information and documentation relating to the formation of the Contract via email or facsimile transmission. Further, the parties would like the option of giving information and notices required by the *Queensland Building and Construction Commission Act 1991* (Qld) and the Contract by electronic communications.

The *Electronic Transactions (Queensland) Act 2001* permits a person to give information and documentation by an electronic communication if at the time the information is given, it is reasonable to expect the information will be readily accessible so as to be useable for subsequent reference, and the person to whom the information is permitted to be given has consented to the information being given by an electronic communication.

CONSENT

The parties consent to the use of the electronic method of delivery described in this form.

The parties agree to electronic communication by way of the email addresses and/or facsimile numbers nominated below.

The parties agree that any information or documentation given by the other party by that method will be deemed to have been given and received:

1. if sent by facsimile transmission, at the time set out in a written confirmation of the successful transmission of the facsimile;
or
2. if sent by email, at the time when the email leaves the relevant system for generating, sending, receiving, storing or otherwise processing electronic communications used by the person by whom, or on whose behalf, the email has been sent.

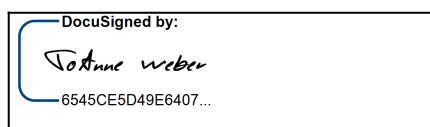
